## 6 new Care Protocols have been introduced<sup>[1]</sup>

**Annual Service Fee (ASF)** <u>Fixed</u> Payment will be provided for enrollees with these 6 chronic conditions. For Healthier SG clinics to receive the full Cardiometabolic, Diabetes, or Respiratory bundle payment, each enrollee must complete the respective bundle based on his/her chronic condition(s) and submit the required care reporting fields.

GPs can view all Care Protocols and required care reporting fields (marked with asterisk\*) in <u>Primary Care Pages</u>.

## New conditions added to Cardiometabolic bundle (i.e. ASF <u>Variable</u> Payment) (5 30

Stable IHD, Stable Stroke and CKD will be categorised under the Cardiometabolic bundle. Please refer below for the number of readings required for the selected cardiometabolic conditions.

Enrollees with multiple CDMP conditions must complete the tests and care report submissions for every CDMP condition they have, in order for the GP to qualify for payment under the Cardiometabolic bundle.

The same care components can fulfil care requirements across multiple Care Protocols. E.g. an enrollee with both DM and HTN only needs 2x BP measurement, not 4x BP measurement in a year, within the same ASF assessment period.
